**RESOLUTION NO. 848-2022**

**DECLARING ORDINANCE NO. 02-2022 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "AN ORDINANCE OTHERWISE KNOWN AS THE BURGOS LOCAL CODE FOR CHILDREN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 02-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with United Convention on the Rights of the Child (CRC), Republic Act No. 7610 of 1992 (Special Protection of Children against Child Exploitation, and Discrimination Act), Presidential Decree No. 603 (The Child and Youth Welfare Code), Sections 17 (b) (iv) and 447 (5) (xiv) of R.A. No. 7160;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to Section 511 (a) of Local Government Code of 1991;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


