RESOLUTION NO. 852-2022

DECLARING ORDINANCE NO. 04, S-2022 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING EDUCATIONAL ASSISTANCE TO ALL FINANCIALLY INCAPABLE COLLEGE STUDENTS OF THE MUNICIPALITY OF INFANTA, PANGASINAN AND APPROPRIATING FUNDS RELATIVE THERETO" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 04, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with 447 (a) (5) (xi) of R.A. No. 7160, 1987 Philippine Constitution, Republic Act No. 109311 otherwise known as "Universal Access to Quality Tertiary Education Act", and Republic Act No. 10648 entitled "An Act Providing Scholarship grants to Top Graduates of all Public High Schools in State Universities and Colleges and Appropriating Funds therefor";

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to Section 59 (a) of Local Government Code of 1991;


