**DECLARING ORDINANCE NO. 2022-002 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, ENTITLED "MODIFYING THE PARENTHETICAL POSITION OF ADMINISTRATIVE AIDE III – SALARY GRADE 3 FROM CLERK I TO UTILITY WORKER II–SALARY GRADE UNDER THE OFFICE OF THE LOCAL CIVIL REGISTRAR, STA. BARBARA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Ordinance No. 2022-002 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, the title of the ordinance should have been modifying the parenthical position of Administrative Aide III - Salary grade 3 from Clerk I to Utility Worker II - Salary Grade 3;


