#### **RESOLUTION NO. 861-2022**

APPROVING RESOLUTION NO. 2022-269 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 4, CY 2022 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2022-269 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council-Executive Committee of Mangaldan, Pangasinan prepared their Supplemental Annual Investment Plan (SAIP) No. 4, CY 2022. This was endorsed by the Council, through MDC-Execom Resolution No. 4, Series of 2022 dated August 19, 2022, to the Sangguniang Bayan for approval;
- 2. Said Supplemental AIP, which has a total investment requirement of ₱3,689,481.50 covers the implementation of the project: Opening and Concreting of Macayug Farm-to-Market Road and Slope Protection, that municipality;

- 3. The identified project, which will be sourced from the Tobacco Excise Tax share of the LGU, conforms with Local Budget Memorandum Nos. 83 and 84 of the Department of Budget and Management; and
- 4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 4, CY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-04, dated September 9, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
