RESOLUTION NO. 862-2022

DECLARING THE SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2022 OF MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P3,689,481.50, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Supplemental Budget No. 4 for Calendar Year 2022 involving total appropriations of P3,689,481.50, which was enacted on September 9, 2022 through Appropriation Ordinance No. 2022-04;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the utilization of appropriations from FY 2018 and FY 2019 shares of the Municipality from Burley and Native Tobacco Excise Tax Collections shall be subject to the provisions of Local Budget Memorandum Nos. 83 and 84 dated November 22, 2021;
- 2. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations);

- 3. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007; and
- 4. That the funding sources for the subject Supplemental Budget were determined in accordance with the provisions of Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 4 for Calendar Year 2022 of Mangaldan, Pangasinan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Mangaldan, Pangasinan, for its information and guidance.
