RESOLUTION NO. 863-2022

DECLARING ORDINANCE NO. 5, S-2022 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "AN ORDINANCE MODIFYING THE POSITION TITLE OF ADMINISTRATIVE ASSISTANT IV (LOCAL CIVIL REGISTRY CLERK), SALARY GRADE 10 TO ADMINISTRATIVE OFFICER I (RECORDS OFFICER I), SALARY GRADE 10 AT THE MUNICIPAL CIVIL REGISTRAR OFFICE, MUNICIPALITY OF SAN QUINTIN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


