**RESOLUTION NO. 864-2022**

**DECLARING ORDINANCE NO. 6, S-2022 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ONE (1) SUPERVISING LABOR AND EMPLOYMENT OFFICER, SALARY GRADE 22 IN THE OFFICE OF THE MUNICIPAL MAYOR, MUNICIPALITY OF SAN QUINTIN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**


