PROVINCIAL RESOLUTION NO. 866-2022

ENJOINING ALL LOCAL GOVERNMENT UNITS, PUBLIC UTILITY TRANSPORT PROVIDERS AND OTHER CONCERNED AGENCIES TO ADOPT AND IMPLEMENT THE LOCAL PUBLIC TRANSPORT ROUTE PLAN OF THE PROVINCE OF PANGASINAN AND THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM OF THE DEPARTMENT OF TRANSPORTATION

WHEREAS, pursuant to Joint Memorandum Circular No. 01, dated June 19, 2017, of the Department of Transportation (DOTr) and the Department of the Interior and Local Government (DILG), the Province of Pangasinan has crafted a Local Public Transport Route Plan (LPTRP) designating and enforcing public transport routes based on the Province's development plans and its mastery of its own mobility and accessibility needs;

WHEREAS, the Notice of Compliance granted to the Province by the the Land Transportation Franchising and Regulatory Board (LTFRB) on October 26, 2022 was the basis of the Sangguniang Panlalawigan of Pangasinan in enacting Provincial Ordinance No. 284-2022 entitled: Adopting the Local Public Transport Route Plan (LPTRP) of the Province of Pangasinan, which was approved on November 7, 2022;

WHEREAS, in the passage of said Ordinance, it is the objective of the Province of Pangasinan to support the policies and programs of the national government by having a detailed plan route network with specific modes of transportation and the required number of units per mode for delivering land transport services in the Province of Pangasinan;

WHEREAS, the Public Utility Vehicle Modernization Program of the Department of Transportation (DOTr) calls for the phasing-out of jeepneys, buses and other public utility vehicles that are at least 15 years old and replacing them with safer, more comfortable and more environmentally-friendly alternatives over the next years;

WHEREAS, the replacement of old public utility vehicles and the transportation route plan are the two main concerns of the DOTr in the implementation of the Public Utility Vehicles Modernization Program (PUVMP);

WHEREAS, adopting and implementing the Local Public Transport Route Plan of the Province of Pangasinan and the Public Utility Vehicle Modernization Program of the Department of Transportation will greatly enhance public transport services around and within the localities of the Province of Pangasinan;


WHEREAS, one of the main thrusts of the Province of Pangasinan is to support the smooth implementation of the programs of the national government which is for the regulation of land-based public transportation, and the safeguarding of the welfare and interests not only of the commuting public but also public transport operators and drivers, not to mention compliance with environmental regulations;

WHEREFORE, in view of the foregoing, on motion of Vice Governor Mark Ronald DG. Lambino, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to enjoin, as they are hereby enjoined, all local government units, public utility transport providers and other concerned agencies to adopt and implement the Local Public Transport Route Plan of the Province of Pangasinan and the Public Utility Vehicle Modernization Program of the Department of Transportation;
