## RESOLUTION NO. 871-2022

**APPROVING RESOLUTION NO. 48, S-2022 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2, FOR FY 2022 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN INVOLVING THE AMOUNT OF FOURTEEN MILLION SIX HUNDRED EIGHTY ONE THOUSAND AND NINETY TWO PESOS (P14,681,092.00)”**

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its SB Resolution No. 48-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Bugallon, Pangasinan prepared their Supplemental Annual Investment Program (SIP) No. 2 for FY 2022. This was endorsed by the Council, through MDC Resolution No. 02, Series of 2022 dated September 9, 2022, to the Sangguniang Bayan for approval;

2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱14,681,092,00 covers the augmentation of funds for Personal Services (PS) and Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some municipal offices, and the implementation of new /reprogrammed projects under the 20% development fund of the LGU. The proposed development projects conform with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects); and
3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2 for FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-02 dated October 3, 2022.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bugallon, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 48, S-2022 of the Sangguniang Bayan of Bugallon, Pangasinan, entitled “Approving Supplemental Investment Program No. 2, for FY 2022 of the Municipality of Bugallon, Province of Pangasinan Involving the Amount of Fourteen Million Six Hundred Eighty One Thousand and Ninety Two Pesos (P14,681,092.00)”;
