RESOLUTION NO. 877-2022

**DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR
CALENDAR YEAR 2022 OF STO. TOMAS, PANGASINAN
INVOLVING TOTAL APPROPRIATIONS OF P3,972,747.91,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Supplemental Budget No. 01, S- 2022 involving total appropriations of P3,972,747.91, which was enacted on September 27, 2022 through Appropriation Ordinance No. 01, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget were determined in accordance with the provisions of Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the reversion of savings from the Personal Services shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

3. That the implementation of the Third Tranche of the Modified Salary Schedule for Local Government Personnel shall be in accordance with the Local Budget Circular No. 143 dated January 3, 2022; and
4. That the appropriation for other Personnel Benefits shall only be disbursed upon issuance of a circular granting the same.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


