APPROVING RESOLUTION NO. 38, S-2022 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PLAN CY 2022 IN THE TOTAL AMOUNT OF TEN MILLION NINE HUNDRED EIGHTY FIVE THOUSAND SEVEN HUNDRED EIGHTY THREE PESOS AND FORTY FIVE CENTS (P10,985,783.45) TO BE ALLOCATED AND UTILIZED FOR THE PURCHASE OF LOT FOR THE PROPOSED CONSTRUCTION OF LEGISLATIVE BUILDING”

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its SB Resolution No. 38, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Umingan, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program through MDC Resolution No. 1, S-2022 dated September 6, 2022 to the Sangguniang Bayan for approval. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;

2. The Supplemental Investment Program with an investment requirement amounting to Php10,985,783.45 covers fund for the purchase of lot for the proposed construction of Legislative Building of LGU Umingan; and
3. The Sangguniang Bayan enacted Supplemental Budget No. 4 through Appropriation Ordinance No. 2, S-2022 dated September 19, 2022 to support the implementation of the Supplemental Investment Program of the municipality.




