RESOLUTION NO. 889-2022

APPROVING RESOLUTION NO. 2022-103 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 CY 2022, AS EMBODIED IN THE MDC RESOLUTION NUMBER 4, SERIES OF 2022 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its SB Resolution No. 2022-103 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bolinao Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 2 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on September 30, 2022 through MDC Resolution No. 4, Series of 2022;
2. Said SIP No. 2 covers fund augmentation for Personal Services (granting of Performance-Based Bonus to all officials and employees), Maintenance and Other Operating Expenses, Capital Outlay of some municipal government offices, and the implementation of priority project of the LGU; and

3. Funding support for the proposed SIP with a total investment requirement of Php59,691,840.14 is embodied in the municipality's Supplemental Budget No. 2 CY 2022, which was approved by their Sangguniang Bayan through Appropriation Ordinance No. 2022-02 on October 4, 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bolinao, Pangasinan;


