RESOLUTION NO. 890-2022

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2022 OF BOLINAO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P59,691,840.14, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Supplemental Budget No. 02 for Calendar Year 2022 involving total appropriations of P59,691,840.14, which was enacted on October 4, 2022 through Appropriation Ordinance No. 2022-02;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the said subject supplemental budget were determined in accordance with Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
3. That all procurements to be undertaken shall be subject to the provisions of R.A.9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
4. That the purchase of motor vehicle shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 re “Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles 2021”; and
5. That the grant of Performance Based Bonus (PBB) for FY 2021 to all municipal officials and employees of the municipality shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring Information and Reporting Systems Memorandum Circular No. 2021-1 dated June 3, 2021.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


