RESOLUTION NO. 891-2022

APPROVING RESOLUTION NO. 100, S-2022 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 4 CY 2022"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its SB Resolution No. 100-S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council-Executive Committee of Aguilar, Pangasinan prepared their Supplemental Annual Investment Program (SIP) No. 4 for CY 2022. This was endorsed by the Council, through MDC-ExeCom Resolution No. 8, S-2022 dated October 14, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of P2,802,941.73, covers the granting of Performance-Based Bonus (PBB) to qualified personnel of the LGU, and implementation of LDRRM projects/activities and other priority projects of the municipality; and

3. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 4 for FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 4, Series of 2022 dated October 17, 2022.




