**RESOLUTION NO. 895-2022**

**DECLARING ORDINANCE NO. 2022-08 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING FRANCHISE TO MR. JOMEL DELA CRUZ FERRER TO OPERATE AND MAINTAIN A COCKPIT ARENA IN THE MUNICIPALITY OF MANGALDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Ordinance No. 2022-08 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;




