DECLARING ORDINANCE NO. 167-050922 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING FIVE HUNDRED (500) SQUARE METERS, MORE OR LESS, OWNED BY MR. ROWEL D. DE GUZMAN SITUATED AT BARANGAY POBLACION ZONE II, VILLASIS, PANGASINAN COVERED UNDER TCT NO. 026-2022004817 FROM AGRICULTURAL LAND TO RESIDENTIAL USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 167-050922 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

WHEREAS, the Municipality of Villasis has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2013-2022 and based on the minutes of the Public Hearing conducted, it showed that said parcel of land is classified as agricultural as certified by the Municipal Planning and Development Coordinator;

De Guzman situated at Barangay Poblacion Zone II, Villasis, Pangasinan covered under TCT No. 026-2022004817 from agricultural land to residential use” as within the conferred powers of the Sanggunian Bayan to enact;
