**RESOLUTION NO. 905-2022**

**DECLARING ORDINANCE NO. 04, S-2022 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "AN ORDINANCE HONORING AND GRANTING CASH INCENTIVES TO CENTENARIANS IN THE MUNICIPALITY OF ROSALES, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Ordinance No. 04, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with R.A. 8972; Republic Act No. 9994, otherwise known as "Expanded Senior Citizens Acts of 2010"; Sections 14 (b) (2) and 447 (a) (5) (xiv) (xvi) of R.A. No. 7160; and Republic Act No. 10686 otherwise known as "An Act Honoring and Granting Additional Benefit and Privileges to Filipino Centenarians, and other Purposes;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 04, S-2022 of the Sangguniang Bayan of Rosales, Pangasinan, entitled "An Ordinance Honoring and Granting Cash Incentives to Centenarians in the Municipality of Rosales, Pangasinan" as within the conferred powers of the Sanggunian Bayan to enact;
