RESOLUTION NO. 907-2022

APPROVING RESOLUTION NO. 2022-072 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2022-002 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF THIRTY-SIX MILLION EIGHT HUNDRED FOUR THOUSAND NINE HUNDRED NINETEEN PESOS AND 44/100 (P36,804,919.44)"

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its SB Resolution No. 2022-072 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Tayug, Pangasinan had identified items in their Supplemental Annual Investment Program for FY 2022. This was endorsed to the Sangguniang Bayan for approval on October 7, 2022 through MDC Resolution No. 2022-03; and
2. The Supplemental Investment Program of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, Capital Outlay of some municipal government offices, and the implementation of priority programs/ projects of the LGU; and

3. Funding support for the implementation of the same in the amount of P36,804,919.44 is embodied in their proposed Supplemental Budget No. 1 for Fiscal Year 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2022-002 on October 10, 2022

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Tayug, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
