APPROVING RESOLUTION NO. 054-2022 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2022-02, SERIES OF 2022 ENTITLED, "ADOPTING REPROGRAMMING OF THE FUNDING FROM THE TWENTY PERCENT (20%) DEVELOPMENT FUND, CALENDAR YEAR 2022 AMOUNTING TO THIRTY ONE MILLION NINE HUNDRED NINETY TWO THOUSAND FIFTY THREE PESOS AND SIXTY EIGHT CENTAVOS (PHP31,992,053.68) TO FINANCE THE IMPLEMENTATION OF HIGHLY PRIORITIZED DEVELOPMENT PROGRAMS, PROJECTS AND ACTIVITIES OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2022 AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL"

1. The Municipal Development Council of Sta. Barbara, Pangasinan endorsed to the Sangguniang Bayan the reprogramming of the Unexpended Funds, amounting to PHP31,992,053.68, from the 20% Development Fund for CY 2022 of the LGU. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2022-02, Series of 2022 dated September 6, 2022 for approval; and
2. The proposed projects conform with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects).
