**APPROVING RESOLUTION NO. 057-2022 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2022-05, SERIES OF 2022 ENTITLED, "ADOPTION OF RESOLUTION ENDORSING THE REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2022 AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL"**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 057-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan proposed for the revision of their Annual Investment Program (AIP) for CY 2022. This was endorsed by the Council, through MDC Resolution No. 2022-05, Series of 2022 dated September 6, 2022, to the Sangguniang Bayan for approval.

2. The LGU revised their AIP, CY 2022 to cover the changes in the Revised Local Disaster Risk Reduction and Management Fund Plan for CY 2022 (as contained in SB Resolution No. 2022-053) in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote:

*Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.*

3. The Revised AIP, CY 2022 also includes the changes in the LGU's 20% Development Plan for CY 2022 (which is the subject of SB Resolution No. 2022-054) and their proposed infrastructure project to be funded under the Local Government Support Fund-Financial Assistance to LGUs (LGSF-FA).
4. Subject Resolution may be considered favorably by the Provincial Board provided that items A.3 and A.4 of this review opinion are complied with by the LGU concerned.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barabara, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr–


