RESOLUTION NO. 923-2022

DECLARING ORDINANCE NO. 4-S-2022 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "CHANGING THE NAME OF SALVADOR ELEMENTARY SCHOOL TO FRANCISCO B. AGBAYANI ELEMENTARY SCHOOL, BY WAY OF HONOR AND PROFOUND GRATITUDE TO THE DONOR OF THE LOT WHERE THE SAID SCHOOL WAS RELOCATED" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 04, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 13 of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 04-2022 of the Sangguniang Bayan of San Fabian, Pangasinan, entitled "Changing the Name of Salvador Elementary School to Francisco B. Agbayani Elementary School, by way of honor and profound gratitude to the donor of the lot where the said school was relocated" as within the conferred powers of the Sanggunian Bayan to enact;


