**RESOLUTION NO. 926-2022**

**DECLARING ORDINANCE NO. 001, S-2022 OF THE SANGGUNIAN BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING ADDITIONAL PLANTILLA POSITIONS IN THE DIFFERENT OFFICES OF THE MUNICIPAL GOVERNMENT OF LINGAYEN AND DEFINING THEIR QUALIFICATIONS, DUTIES AND FUNCTIONS"**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 001, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, however the Sangguniang Bayan shall be subject to Section 325 (a) of RA 7160 and the LBC No. 145 dated March 2, 2022, particularly Items 4.2.7 and 4.2.8 thereof;


