**PROVINCIAL RESOLUTION NO. 927-2022**

**RESOLUTION TO DEFER THE HOLDING OF MOTORSHOWS IN THE PROVINCE OF PANGASINAN, PARTICULARLY THOSE THAT FEATURE, DISPLAY AND DEMONSTRATE MOTORCYCLES WITH MODIFIED ENGINES, EXHAUST SYSTEMS AND OTHER MECHANICAL ENHANCEMENTS UNTIL THE RECENT INCIDENT IN MAPANDAN IS INVESTIGATED AND SAFETY PRECAUTIONS ARE FORMULATED AND IMPLEMENTED BY THE CONCERNED OFFICES AND DEPARTMENTS AS WELL AS OTHER STAKEHOLDERS**

**WHEREAS**, the Local Government Code dictates that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.

**WHEREAS**, motorshows that feature motorcycles having enhanced engine, exhaust systems and other modifications are regularly held in various places in the Province and attended by enthusiasts and interested members of the public;

**WHEREAS**, during such shows, these motorcycles are operated outside their manufacturers' suggested safety recommendations thus resulting unmonitored and unregulated production of noise, fumes and heat that may damage the motorcycle and harm not only the participants but also the spectators,

**WHEREAS**, an unfortunate incident in a similar motorshow happened recently in Mapandan, Pangasinan, resulting in the untimely death of a 16-year old boy and the injury of several others including the operator of the motorcycle.

**NOW THEREFORE**, in view of the foregoing, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was –




