PROVINCIAL RESOLUTION NO. 928-2022

AUTHORIZING THE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRARIAN REFORM UNDER THE AGRARIAN REFORM FUNDS/AGRARIAN REFORM COMMUNITIES (ARF/ARC) PROJECT FOR THE CONCRETING OF ROADS (FARM TO MARKET ROADS) IN THE DIFFERENT BARANGAYS OF THE PROVINCE OF PANGASINAN

WHEREAS, pursuant to the General Welfare Clause of Republic Act 7160, otherwise known Local Government Code of 1991, it is the declared the policy of the Provincial Government of Pangasinan in partnership with component local government units, national government agencies and the private sector to enhance the quality of life of every Pangasinense consistent with the principles of sustainable development and responsible stewardship;

WHEREAS, Department of Budget and Management (DBM) issued Special Allotment Release Order (SARO) to the Department of Agrarian Reform under the Agrarian Reform FUND (ARF), wherein the amount of **ONE HUNDRED MILLION PESOS** (P100,000,000.00) for the concreting of road (farm to market roads) of twenty (20) different barangays in the Province of Pangasinan at Five Million (P5,000,000.00), shall be charged;

WHEREAS, consistent with the provision of RA 6657 on the implementation of the infrastructure support component of the Comprehensive Agrarian Reform Program (CARP), the Provincial Government of Pangasinan has been tasked to implement farm to market roads, bridges and multi-purpose pavement (MPP);

WHEREAS, the Provincial Government of Pangasinan shall receive the funds for the said project being the implementing agency for the concreting the said farm to market roads;



WHEREFORE, in view of the foregoing, on motion of Napoleon C. Fontelera, Jr., duly seconded, it was –


