PROVINCIAL RESOLUTION NO. 938-2022

AUTHORIZING THE PROVINCIAL ADMINISTRATOR, MR. MELECIO F. PATAGUE II, TO BE ONE OF THE OFFICIAL SIGNATORIES OF THE PROVINCIAL GOVERNMENT OF PANGASINAN WITH LAND BANK OF THE PHILIPPINES, DEVELOPMENT BANK OF THE PHILIPPINES AND OTHER GOVERNMENT DEPOSITORY BANKS OF THE PROVINCE

WHEREAS, the Sangguniang Panlalawigan has already authorized the Provincial Governor and the Provincial Treasurer to be the official signatories of the accounts of the Provincial Government of Pangasinan with government depository banks of the Province;

WHEREAS, there is a need to add the signatories of the Provincial Government of Pangasinan with government depository banks in order to have uninterrupted transactions with the said banks;

WHEREAS, Administrative Order Nos. 0024, S-2022 and 0049, S-2022, of the Provincial Governor, both dated July 7, 2022 and July 28, 2022, authorized the Provincial Administrator, Mr. Melecio F. Patague II, to sign for and in behalf of the Provincial Governor with the official transactions of the Province;

WHEREAS, it is necessary therefore, to authorize the Provincial Administrator to be one of the official signatories of the Provincial Government of Pangasinan with Land Bank of the Philippines, Development Bank of the Philippines and other government depository banks of the Province;


