APPROVING RESOLUTION NO. 408, S-2022 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 4 WITH THE CY 2022 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 3 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its SB Resolution No. 408-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

 Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Asingan, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 3 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on October 14, 2022 by the Municipal Development Council through Resolution No. 4 S-2022;

- 2. The SIP No. 3 of the municipality covers fund augmentation for Personal to include payment of Performance Based Bonus (PBB) and Other Benefits of LGU-Asingan Employees;
- 3. Funding support for the implementation of the same in the amount of PhP5,915,311.00 is embodied in their proposed Supplemental Budget No. 3 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 3, Series of 2022 on October 17, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
