DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2022 OF ASINGAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P5,915,311.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2022 involving total appropriations of P5,915,311.00, which was enacted on October 17, 2022 through Appropriation Ordinance No. 3-2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- 1. That the reversion of savings from the Personal Services shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);
- 2. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;

- That the grant for Performance-Based Bonus for Calendar Year 2021 (PBB) for all municipal officials and employees of the municipality shall be in accordance with the provisions of Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2021-1 dated June 3, 2021; and
- That the appropriation for other Personnel Benefits shall only be disbursed upon issuance of a circular granting the same.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;
