PROVINCIAL RESOLUTION NO. 963-2022

REQUESTING THE HONORABLE CONGRESSMEN OF THE PROVINCE OF PANGASINAN INCLUDING THE ABONO AND ABANTE PANGASINAN ILOKANO PARTYLISTS TO SUPPORT THE ESTABLISHMENT OF PHILIPPINE STATISTICS AUTHORITY (PSA) SATELLITE OFFICES IN THE EASTERN AND WESTERN PARTS OF PANGASINAN

WHEREAS, the Philippine Statistics Authority (formerly National Statistics Office) is one of the frontline services of the national government with the main function of planning, developing, prescribing, disseminating and enforcing policies, rules and regulations and coordinating government-wide programs governing the production of official statistics, general-purpose statistics, and civil registration services;

WHEREAS, the Province of Pangasinan is the biggest province in Region I comprising of 44 municipalities and 3 cities but only one office of the Philippine Statistics Authority (PSA) is serving the entire province which is located at the central part of Pangasinan in Calasiao;

WHEREAS, the Philippine Statistics Authority Calasiao is rendering service to hundreds of clients every working day coming from east to west parts of the Province, and the people are sometimes queueing in long lines and braving rains and heat of the sun to request for the issuance of birth certificate, marriage certificate, certificate of no marriage record (CENOMAR), death certificate and other documents;

WHEREAS, with the establishment of Philippine Statistics Authority satellite offices in the eastern and western parts of Province, it is the aim of the Provincial Government to provide more convenience to Pangasinenses living in municipalities and cities with considerable distance from Calasiao, and to avoid unnecessary health risks;

WHEREAS, the establishment of satellite offices in the eastern and western parts of the Province would further enhance effective and efficient services to the people;




