PROVINCIAL RESOLUTION NO. 964-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD) FOR THE IMPLEMENTATION OF THE PAMBANSANG PABAHAY PARA SA PILIPINO: ZERO ISF 2028 PROGRAM IN THE PROVINCE OF PANGASINAN

WHEREAS, Republic Act No. 7279, known as the Urban Development and Housing Act of 1992 and Republic Act 7160, known as the Local Government Code of 1991, mandated Local Government Units (LGUs) to take the principal role in the provision of shelter to homeless and underprivileged families;

WHEREAS, Section 17 (a) (b) (3) (viii) of RA 7160, known as the Local Government Code, provides that the Province shall implement “programs and projects for low-cost housing and other mass dwellings..”;

WHEREAS, Republic Act 110201 created the Department of Human Settlements and Urban Development (DHSUD) and its attached Key Shelter Agencies (KSAs), namely: National Housing Authority (NHA), Home Development Mutual fund (commonly known as the Pag-Ibig Fund), Social Housing Finance Corporation (SHFC) and the National Home Mortgage Finance Corporation (NHMFC), which shall act as the primary national government agencies responsible for the management of housing, human settlement, and urban development;

WHEREAS, the DHSUD launched the “Pambansang Pabahay Para sa Pilipino: Zero Informal Settler Families (ISF) that targets to build one hundred million housing units per year or a total of six million housing units for six (6) years;

WHEREAS, the program aims to develop housing projects for the benefit of the residents of Pangasinan, especially the Informal Settler Families (ISFs) living in danger areas and those in areas earmarked for government infrastructure projects;

WHEREFORE, in view of the foregoing, on motion of SP Member Philip Theodore E. Cruz, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Understanding (MOU) with the Department of Human Settlements and Urban Development (DHSUD) for the implementation of the Pambansang Pabahay Para Sa Pilipino: Zero ISF 2028 Program in the Province of Pangasinan;
