### PROVINCIAL RESOLUTION NO. 972-2022

#### **AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE TO THE CALAMITY VICTIMS CAUSED BY SEVERE TROPICAL STORM “PAENG” IN THE MUNICIPALITY OF KALIBO, AKLAN AND THE PROVINCES OF MAGUINDANAO AND ANTIQUE**

**WHEREAS**, the Sangguniang Panlalawigan is in receipt of Provincial Disaster Risk Reduction and Management Council (PDRPMC) Resolution No. 6, S-2022, dated November 22, 2022, “Extending Financial Assistance in the Total Amount of Two Million Pesos (P2,000,000.00)-One Million Pesos (P1,000,000.00) to the Provincial Government of Maguindanao, and Five Hundred Thousand Pesos (P500,000.00) Each to the Municipality of Kalibo, Aklan, and the Provincial Government of Antique due to Severe Tropical Storm *Paeng*”;

**WHEREAS**, the Provinces of Maguindanao and Antique, and the Municipality of Kalibo, Aklan were declared under a state of calamity after the areas were devastated by Severe Tropical Storm “Paeng” on October 29, 2022;

**WHEREAS**, the affected areas have suffered massive flooding causing millions worth of damages to agriculture including the loss of lives;

**WHEREAS**, the Provincial Government of Pangasinan opted to extend financial assistance in the amount of P1,000,000.00 to the Province of Maguindanao, and P500,000.00 each to the beleaguered areas of the Municipality of Kalibo, Aklan and the Province of Antique;

**WHEREAS**, the above-significant humanitarian endeavor of the Provincial Government of Pangasinan will greatly benefit thousands of families in the areas that were affected by the onslaught of Severe Tropical Storm “Paeng”;

**WHEREFORE**, on motion of all Members of the Sangguniang Panlalawigan, duly seconded, it was –


