## **PROVINCIAL RESOLUTION NO. 973-2022**

## APPROVING THE CONTINGENCY PLAN FOR MASSIVE FLOODING, DAM BREAK AND TYPHOON IN THE OCCURRENCE OF EMERGING INFECTIOUS DISEASE IN THE PROVINCE OF PANGASINAN

WHEREAS, Section 29(a) of RA 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 mandates that the state shall uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, Section 2(b) states that the government shall adhere to and adopt the universal norms, principles, and standards of humanitarian assistance and the global effort on risk reduction as a concrete expression of the country's commitment t to overcoming human suffering due to recurring disasters;

WHEREAS, Section 12(8) of RA 10121 decrees Local Disaster Risk Reduction and Management Office (LDRRMO) shall conduct continuous disaster monitoring and mobilize instrumentalities and entities of the LGUs, CSOs, private groups, and organized volunteers to utilize their facilities and resources for the protection and preservation of life and properties during emergencies in accordance with existing policies and procedures;

WHEREAS, Section 16 of the same law directs the LDRRMO to respond to and manage the adverse effects of emergencies and carry out recovery activities in the affected area, ensuring that there is an efficient mechanism for immediate delivery of food, shelter and medical supplies for women and children;

> WHEREAS, National Disaster Risk Reduction and Management Council Memorandum No. 76 s. 2022 in relation to Memorandum No. 131 s.2018 and Executive Order No. 138 of the Full Devolution mandate calls for strengthening of LDRRMOs capabilities through leveraging on the use of resources and assets as well as investment in DRR-related programs for Emergency Operations;

> WHEREAS, Rule 6, Section 4 (3) of Republic Act No. 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010 provides that provincial, city and municipal Disaster Risk Reduction and Management Offices (DRRMOs) or Barangay Disaster Risk Reduction and Management Councils (BDRRMCs), in coordination with concerned national agencies and instrumentalities, shall facilitate and support risk assessments and contingency plan activities at the local level;

> WHEREAS, 6.1.1 of NDRRMC-NSC JMC No. 1, S-2016 mandates that all Disaster Risk Reduction and Management Councils at all levels, individual government departments, bureaus, agencies, offices, units and instrumentalities shall formulate contingency plans for natural and/or human-induced hazards appropriate to their areas in accordance with the prescribed Contingency Planning Guidebook;

> WHEREAS, the Sangguniang Panlalawigan is in receipt of PDRRMC Resolution No. 4, S-2022 entitled "Resolution on Approving the Contingency Plan for Massive Flooding, Dam Break and Typhoon in the Occurrence of Emerging Infectious Disease in the Province of Pangasinan";

> WHEREAS, the Provincial Government of Pangasinan, through the Provincial Disaster Risk Reduction and Management Office, has formulated the Contingency Plan Massive Flooding, Dam Break and Typhoon that will serve as preparedness measure of the Province and to integrate the plan on Emerging and Re-Emerging Infectious Disease in order to adapt to the new normal and the possibility of the occurrence of emerging infectious disease;

WHEREAS, the Sangguniang Panlalawigan fully supports the contingency plan of the Province in order to help and protect lives and ensure the availability of resources and likewise establishes a mechanism for rapid decision-making based on authority, responsibility and accountability;

WHEREFORE, in view of the foregoing, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled to approve, as it is hereby approved, the Contingency Plan for Massive Flooding, Dam Break and Typhoon in the Occurrence of Emerging Infectious Disease in the Province of Pangasinan;
