RESOLUTION NO. 978-2022

DECLARING ORDINANCE NO. 2022-13 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE PRESCRIBING FEES FOR MEDICINES, SUPPLIES AND SERVICES PROVIDED TO PATIENTS AT THE ALAMINOS CITY DIALYSIS CLINIC, AMENDING FOR THIS PURPOSE SECTION 5 OF ORDINANCE NO. 2021-02 AND REPEALING ORDINANCE NO. 2022-07 ENACTED ON 27 JUNE 2022 OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


