RESOLUTION NO. 980-2022

DECLARING ORDINANCE NO. 04-2022 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF SENIOR ADMINISTRATIVE ASSISTANT II (COMPUTER OPERATOR IV), SALARY GRADE 14 UNDER THE OFFICE OF THE MUNICIPAL TREASURER, SUAL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 04-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 04-2022 of the Sangguniang Bayan of Sual, Pangasinan, entitled "An Ordinance creating the position of Senior Administrative Assistant II (Computer Operator IV), Salary Grade 14 under the Office of the Municipal Treasurer, Sual, Pangasinan" as within the conferred powers of the Sanggunian Bayan to enact;




