**RESOLUTION NO. 982-2022**

**APPROVING RESOLUTION NO. 103, S-2022 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2022 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its SB Resolution No. 103, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Lingayen, Pangasinan proposed for the revision of their Annual Investment Program (AIP) for CY 2022. This was endorsed by the Council, through MDC Resolution No. 03, Series 2022 dated September 20, 2022, to the Sangguniang Bayan for approval;
2. The LGU revised their AIP for CY 2022 to include the project, Purchase/Acquisition of Vacuum Truck/Declogger Machine, to be funded from the Unutilized Local Disaster Risk Reduction and Management (LDRRM) Fund (CY 2019, 2020 and 2021) amounting to P8,000,000.00, which emanated from the LDRRMC and approved thru MDRRM Council Resolution No. 03, S-2022 dated August 4, 2022. This is in pursuance to Section 6.5 of the NDRRMC-DILG-DBM JMC

No. 2013-1 dated March 25, 2013, to quote: "Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP"; and

3. The proposed project conforms with NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, particularly Section 5 (Utilization of the LDRRMF/Projects and Activities).




