#### **RESOLUTION NO. 985-2022**

#### DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALNDAR YEAR 2022 OF MANAOAG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P7,782,430.33, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2022 involving total appropriations of P7,782,430.33, which was enacted on October 11, 2022 through Appropriation Ordinance No. 02, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;

- That the purchase of motor vehicle shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 re "Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles 2021;
- That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993; and
- 4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. de Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
