**APPROVING RESOLUTION NO. 326, S-2022 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 5, S.2022 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 2 CY 2022 AMOUNTING TO ONE MILLION SEVEN HUNDRED NINETY THREE THOUSAND EIGHT HUNDRED EIGHT PESOS AND 80/100 (P1,793,808.80)”**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its SB Resolution No. 326, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bautista, Pangasinan had identified items in their Supplemental Investment Program for CY 2022. This was endorsed to the Sangguniang Bayan for approval on November 8, 2022 by the Municipal Development Council Executive Committee through MDC Resolution No. 5, S. of 2022;

2. Said SIP of the municipality covers fund augmentation for Personal Services (granting of Performance-Based Bonus to all officials and employees), Maintenance and Other Operating Expenses, and the implementation of disaster risk reduction programs/projects of the LGU; and
3. Funding support for the proposed SIP, with a total investment requirement of PhP1,793,808.80 is embodied in the municipality's Supplemental Budget No. 2 CY 2022, which was approved and enacted by their Sangguniang Bayan on November 14, 2022 thru Appropriation Ordinance 2, S. of 2022.




