## **RESOLUTION NO. 994-2022**

APPROVING RESOLUTION NO. 22-35 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 0222-2 EMBODYING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 2 FOR FY 2022 OF THE MUNICIPALITY OF STA. MARIA, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its SB Resolution No. 22-35 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Sta. Maria, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 02 for FY 2022. This was endorsed to the Sangguniang Bayan for approval on September 7, 2022 by the Municipal Development Council through Resolution No. 2022- 2;
- The SAIP No. 2 of the municipality covers fund augmentation for Maintenance and Other Operating Expenses of some municipal offices and implementation of disaster reduction programs and development projects of the Local Government Unit of Sta. Maria; and

3. Funding support for the implementation of the same in the amount of Php 18,000,000.00 is embodied in their proposed Supplemental Budget No. 2 for Calendar Year 2022 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 22-02 on October 18, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Maria, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
