PROVINCIAL RESOLUTION NO. 380-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A SUPPLEMENTAL AGREEMENT WITH JTI JISEDAI TELECOM INCORPORATED FOR THE MODIFICATION OF THE EXISTING MEMORANDUM OF AGREEMENT FOR THE IMPLEMENTATION OF THE UNDERGROUND CABLING PROJECT IN THE PROVINCE OF PANGASINAN

WHEREAS, on August 13, 2023, the Provincial Government of Pangasinan and JTI JISEDAI Telecom Incorporated executed a Memorandum of Agreement for the implementation of the Underground Cabling Project within the Province of Pangasinan, whereby JTI agreed to design, construct, and install underground cabling infrastructure to replace existing aerial backbone cables;

WHEREAS, the Sangguniang Panlalawigan of Pangasinan enacted Provincial Ordinance No. 299-2023, otherwise known as the Underground Cabling Ordinance of the Province of Pangasinan", mandating the relocation of aerial backbone cables to underground infrastructure in accordance with the approved Implementing Rules and Regulations (IRR) of said Ordinance;

WHEREAS, in order to realize the foregoing goal, the Provincial Government of Pangasinan and JTI JISEDAI Telecom Incorporated have mutually agreed to amend and supplement the terms and conditions of the original Memorandum of Agreement to conform with the approved Implementing Rules and Regulations (IRR) of Provincial Ordinance No. 299-2023;

WHEREAS, the amendment will cover certain provisions of the existing Memorandum of Agreement concerning the revised project timeline, performance obligations, reporting requirements, and the extension of the completion period of Phase I of the Underground Cabling Project, in order to ensure the continuous implementation of the Project and to identify the specific terms required in the agreement;

WHEREAS, the Sangguniang Panlalawigan expresses its support to this Project in order to improve the information communication technology of the Province;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (1) (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;

WHEREAS, for the above purpose, a Supplemental Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor, Ramon V. Guico III; and the JTI JISEDAI Telecom Incorporated, represented by its President, Mr. Christopher G. Dueñas;

NOW, THEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Supplemental Agreement with the JTI JISEDAI Telecom Incorporated for the modification of the existing Memorandum of Agreement for the implementation of the Underground Cabling Project in the Province of Pangasinan;

RESOLVED FINALLY, to furnish copies of this resolution to Honorable Governor Ramon V. Guico III, Province of Pangasinan, and Mr. Christopher G. Dueñas, President, JTI JISEDAI Telecom Incorporated, for their information and guidance.
