### PROVINCIAL RESOLUTION NO. 381-2025

**AUTHORIZING THE PROVINCIAL GOVERNOR, HON. RAMON V. GUICO III, TO REQUEST FOR A CERTIFICATE OF EXEMPTION FOR THE PROVINCIAL GOVERNMENT OF PANGASINAN'S SOCIAL WELFARE AND SERVICES PROJECTS FROM THE COMMISSION ON ELECTIONS (COMELEC)**

**WHEREAS**, there will be an upcoming National and Local Elections, and BARMM Parliamentary Elections where the Commission on Elections (COMELEC) is mandated by the 1987 Philippine Constitution to enforce and administer all laws and regulations relative to the conduct of an election, plebiscite, initiative, referendum, and recall;

**WHEREAS**, on September 13, 2024, the (COMELEC) issued Resolution No. 11060 or the “Rules and Regulations on Prohibition Against Release, Disbursement or Expenditure of Public Funds for Social Services and Housing-Related Projects, and Issuance of Treasury Warrants and Similar Devices Under Sections 261 (v) and (w) of the Omnibus Election Code in Connection with the May 12, 2025 National and Local Elections and BARMM Parliamentary Elections”;

**WHEREAS**, Rule II, Section 2 of the said resolution provides that the release of public funds for social welfare and services projects from March 28, 2025 (Friday) to May 11, 2025 (Sunday) is prohibited, except as authorized by COMELEC, and it specifically prohibits the disbursement and expenditures of social services of all LGUs during the forty-five (45) day election ban including the Province of Pangasinan, particularly the provision states;

**WHEREAS**, the Provincial Government of Pangasinan is currently implementing worthy programs, projects and activities (PPAs) of the Province especially on health reform and other social welfare assistance and it aims to have a continuity of these services rendered to the people amidst the upcoming local and national elections;

**WHEREAS**, in the establishment of the Pangasinan Government Unified Incentives for Medical Consultation Program in pursuance to the provisions of the Universal Health Care Act and Philhealth Konsulta with the aim to promote preventive health care for every Pangasinense, the Province of Pangasinan provides a combination of services;

**WHEREAS**, the Province of Pangasinan is likewise implementing the Serbisyon Ang Galing para sa *alagang hayop* (companion and ruminant animals) and Information Drive Campaign on Rabies Awareness or Rabies Control Program,

**WHEREAS**, the Provincial Government of Pangasinan would like to seek an exemption from the prohibition against the release, disbursement or expenditure of public funds in the implementation of the services under the Unified Incentives Program and Rabies Control Program, to include the following regular and long-established PPAs:

1. Expenses incidental to the implementation of the Pangasinan Government Unified Incentive for Medical Consultation Program
2. Food Assistance to indigent individuals or families
3. Provision of various veterinary services;

**WHEREAS**, it is the primordial concern of the Provincial Government of Pangasinan to guarantee the uninterrupted provision of healthcare and other necessary services to every Pangasinense especially the underprivileged;

**NOW, THEREFORE**, on motion of Vice Governor Mark Ronald DG. Lambino, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to request for a Certificate of Exemption for the Provincial Government of Pangasinan's social welfare and services projects from the Commission on Elections (COMELEC);

**RESOLVED, FINALLY**, that a copy of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan, for his information and guidance.
