RESOLUTION NO. 389-2025

DECLARING ORDINANCE NO. 2024-06 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE "KATUWANG SA DIWA AT GAWA PARA SA MASAGANANG ANI AT MATAAS NA KITA NG PANGULO", IN THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2024-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Section 16 of Republic Act No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2024-06 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled "An Ordinance institutionalizing the "Katuwang sa Diwa at Gawa para sa Masaganang Ani at Mataas na Kita ng Pangulo" as within the conferred powers of the Sangguniang Panlungsod to enact;
