**APPROVING RESOLUTION NO. 15, S-2025 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “APPROVING RESOLUTION NO. 2, SERIES OF 2025 OF THE MUNICIPAL DEVELOPMENT COUNCIL, CALASIAO, PANGASINAN ENTITLED “RESOLUTION STRONGLY ENDORSING THE VARIOUS INFRASTRUCTURE PROJECTS IN THE TOTAL AMOUNT OF P300,000,000.00 FOR IMPLEMENTATION BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS REGIONAL OFFICE 1, AGUILA ROAD, 2500 SAN FERNANDO CITY, LA UNION, REGION 1”**

**WHEREAS**, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 15, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program No. 4 for CY 2025. This was endorsed by the Council, through MDC Resolution No. 2, Series of 2025 dated January 31, 2025, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991; and

2. Said Supplemental Annual Investment Program, which has a total investment requirement of Php555,000,000.00, covers various infrastructure projects proposed to be funded by the DPWH-Region I in the amount of Php300,000,000.00, and other priority projects of the LGU proposed for funding from other National Government Agencies.


