S-2025 OF THE RESOLUTION NO. 15, APPROVING PANGASINAN, **BAYAN** CALASIAO, SANGGUNIANG ENTITLED "APPROVING RESOLUTION NO. 2, SERIES OF 2025 OF THE MUNICIPAL DEVELOPMENT COUNCIL, CALASIAO, "RESOLUTION **STRONGLY PANGASINAN ENTITLED** ENDORSING THE VARIOUS INFRASTRUCTURE PROJECTS IN **AMOUNT OF** P300,000,000.00 TOTAL IMPLEMENTATION BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS REGIONAL OFFICE 1, AGUILA ROAD, 2500 SAN FERNANDO CITY, LA UNION, REGION 1"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 15, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program No. 4 for CY 2025. This was endorsed by the Council, through MDC Resolution No. 2, Series of 2025 dated January 31, 2025, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991; and

2. Said Supplemental Annual Investment Program, which has a total investment requirement of Php555,000,000.00, covers various infrastructure projects proposed to be funded by the DPWH-Region I in the amount of Php300,000,000.00, and other priority projects of the LGU proposed for funding from other National Government Agencies.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—
