RESOLUTION NO. 407-2025

APPROVING SB RESOLUTION NO. 180-2024 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 003-2024 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Resolution No. 180-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 03, CY 2024 of the LGU. This was endorsed by the Council, through MDC Resolution No. 05-2024, Series of 2024 dated December 12, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP, which has a total investment requirement of P23,462,927.58, covers the augmentation of funds for Personal Services (granting of Performance-Based Bonus, Service Recognition Incentive and Collective Negotiation Agreement Incentive to Qualified LGU Personnel) and Maintenance and Other Operating Expenses (Gratuity Pay/Financial Assistance to Contract of Service and Job Order Workers), and implementation of LDRRM projects/activities and other priority projects of the municipality.

It is recommended, however, that the LGU shall use the new prescribed AIP Summary Form in their succeeding Supplemental AIPs as per Local Budget Memorandum No. 87 dated June 9, 2023; and

3. Funding support for the full implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 3, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 004-2024, dated December 16, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Malasiqui, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 180-2024 of the Sangguniang Bayan of Malasiqui, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 003-2024 of the Municipality of Malasiqui, Pangasinan";
