**RESOLUTION NO. 423-2025**

**DECLARING ORDINANCE NO. 10-2024 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE POSITION OF ENGINEER III (AGRICULTURAL AND BIOSYSTEMS) WITH SALARY GRADE 19 AND APPROPRIATING FUNDS THEREOF UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURE OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Ordinance No. 10-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of Republic Act No. 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 10-2024 of the Sangguniang Bayan of San Jacinto, Pangasinan, entitled “An Ordinance creating the position of Engineer III (Agricultural and Biosystems) with Salary Grade 19 and appropriating funds thereof under the Office of the Municipal Agriculture of the Municipality of San Jacinto, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
