RESOLUTION NO. 433-2025

DECLARING MUNICIPAL ORDINANCE NO. 2025-02 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE CREATING VARIOUS POSITIONS OF THE MUNICIPAL GOVERNMENT OF ALCALA, PANGASINAN, DETERMINING ITS DUTIES AND RESPONSIBILITIES, AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Ordinance No. 2025-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of Republic Act No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2025-02 of the Sangguniang Bayan of Alcala, Pangasinan, entitled “An Ordinance creating various positions of the Municipal Government of Alcala, Pangasinan, determining its duties and responsibilities, and providing funds thereof” as within the conferred powers of the Sangguniang Bayan to enact;


