RESOLUTION NO. 434-2025

APPROVING RESOLUTION NO. 436, S-2025 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 1, S. OF 2025 REVISING THE ANNUAL INVESTMENT PROGRAM OF CY 2025 OF THE MUNICIPALITY OF BAUTISTA”

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 436, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bautista, Pangasinan has identified items in their Revised Annual Investment Program for CY 2025. This was endorsed to the Sangguniang Bayan on January 22, 2025 through MDC Resolution No. 1, S. of 2025;
2. The AIP of LGU Bautista was revised to integrate the proposed disaster risk reduction and management programs/projects/activities to be funded from the unexpended balances of the LGU's LDRRM Fund CY 2020, 2021, 2023 and 2024 amounting to Php 4,656,880.87, which has emanated from the MDRRM Council through Resolution 01, Series of 2025 dated January 15, 2025. This is in pursuance to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states:

“The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP”; and

3. These disaster risk reduction and management programs are based on the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


