APPROVING RESOLUTION NO. 437, S-2025 OF THE SANGGUNANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2, S-2025 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM AMOUNTING TO ONE MILLION SIX HUNDRED FORTY EIGHT THOUSAND EIGHT HUNDRED FOUR PESOS AND 72/100 (P1,648,804.72)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 437, Series of 2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program No. 2. This was endorsed to the Sangguniang Bayan for approval on January 22, 2025 by the Municipal Development Council-Executive Committee thru Resolution No. 2, S. of 2024;
2. The SAIP covers implementation of the Renovation of Vacante Evacuation Center-Phase II of the LGU; and

3. Funding support for the full implementation of the same in the amount of PhP1,648,804.72, is embodied in their Supplemental Budget No. 1 for CY 2025 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 1, S. of 2025 on January 27, 2025.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;
