RESOLUTION NO. 437-2025

DECLARING MUNICIPAL ORDINANCE NO. 03, S-2024 OF THE SANGGUNIANG BAYAN OF SANTO TOMAS, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE TOURISM CODE OF THE MUNICIPALITY OF SANTO TOMAS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Santo Tomas, Pangasinan submitted its Ordinance No. 03, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (2) (vi) & 447 (a) (1) & (iii) of R. A. No. 7160; and Republic Act No. 9593, also known as the "Tourism Act of 2009";

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 03, Series of 2024 of the Sangguniang Bayan of Santo Tomas, Pangasinan, entitled "An Ordinance Enacting the Tourism Code of the Municipality of Santo Tomas, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
