RESOLUTION NO. 444-2025

DECLARING ORDINANCE NO. 19-2024 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF ROSALES, PANGASINAN, REPRESENTED BY ITS MUNICIPAL MAYOR, HON. WILLIAM S. CEZAR, AND THE LAND BANK OF THE PHILIPPINES, REPRESENTED BY ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, CESAR N. ULPINDO, IN THE AMOUNT NOT EXCEEDING ONE HUNDRED TWENTY MILLION PESOS (P120,000,000.00) TO FUND THE FOLLOWING: (1) PURCHASE OF LOTS; (2) LAND/SITE DEVELOPMENT AND CONSTRUCTION OF MATERIALS RECOVERY FACILITY; (3) PURCHASE OF HEAVY TRUCKS AND EQUIPMENT; TWO (2) UNITS BRAND NEW GARBAGE COMPACTORS; ONE (1) UNIT BRAND NEW BULLDOZER; TWO (2) UNITS BRAND NEW DUMP TRUCKS, AS INCLUDED IN THE APPROVED ANNUAL/SUPPLEMENTAL INVESTMENT PROGRAM FOR CY 2025” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its Municipal Ordinance No. 19-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Provincial Planning and Development Coordinator have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 22 (a) (5) (c), 296 (a) (b), 297 (a) (b) (c), 444 (1) (vi) & 447 (a) (2) (iii) (iv) of R. A. No. 7160;

WHEREAS, the projects to be funded by the proposed borrowing are included in the Annual Investment Plan for CY 2025 of the municipality which was approved by the Sangguniang Bayan on November 25, 2024;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 19-2024 of the Sangguniang Bayan of Rosales, Pangasinan, entitled “An Ordinance approving and ratifying the terms and conditions of the approved loan and other supporting documents pertaining to the loan entered into by and between the Municipal Government of Rosales, Pangasinan, represented by its Municipal Mayor, Hon. William S. Cezar, and the Land Bank of the Philippines, represented by its Assistant Vice President/Head, Pangasinan Lending Center, Cesar N. Ulpindo, in the amount not exceeding One Hundred Twenty Million Pesos (P120,000,000.00) to fund the following: (1) Purchase of Lots; (2) Land/Site Development and Construction of Materials Recovery Facility; (3) Purchase of Heavy Trucks and Equipment; two (2) Units Brand New Garbage Compactors; one (1) Unit Brand New Bulldozer; two (2) Units Brand New Dump Trucks, as included in the approved Annual/Supplemental Investment Program for CY 2025” as within the conferred powers of the Sangguniang Bayan to enact;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Rosales, Pangasinan, for its information and guidance.
