DECLARING MUNICIPAL ORDINANCE NO. 2, S-2025 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "AN ORDINANCE ABOLISHING THE POSITION ASSISTANT REGISTRATION OFFICER (SG 8) IN THE MCR OFFICE AND CREATING THE POSITIONS OF ADMIN AIDE III (DRIVER I) (SG 3) IN THE MAYOR'S OFFICE AND REGISTRATION OFFICER I (SG 10) IN THE MCR OFFICE IN THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Municipal Ordinance No. 2, S-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 & 447 (a) (1) (viii) of R. A. No. 7160;

WHEREAS, the Local Chief Executive in coordination with the Municipal Local Finance Committee shall provide a supplemental budget for the implementation of the subject ordinance;
